Designed for application over previously painted surface areas and plastics, as well as removing mould release agents and light surface dirt and grime. Recommended to use before applying DNA® Virtual Chrome™, DNA® Black Chrome™, DNA® HolaChrome™, DNA® HolaSpeX™, DNA® HolaGrafiX™ and similar products, or where static electricity may be a problem. DNA® Anti Static Cleaner eliminates the electrostatic charge on the surface and reduces dust and air borne particles attracted to the charge which can cause paint inclusions.

**SDS:** Observe all safety precautions in relation to this product. Always wear appropriate PPE such as gloves, spray suit, breathing mask etc.



**Always test on a small inconspicuous area for compatibility.**

1. Wipe dry with clean cloth or blow dry with de-ionised air.
2. Soak a clean lint free cloth with DNA® Anti Static Cleaner.
3. Treat only one small area at a time using a 'two-rag wipe' technique, wet one rag with DNA® Anti Static Cleaner and wipe the entire surface area with it and do not allow to evaporate from the surface.
4. Use the second rag to immediately wipe the wet DNA® Anti Static Cleaner from the surface before it evaporates! Allowing DNA® Anti Static Cleaner to dry on the surface without wiping re-deposits the surface grime as the DNA® Anti Static Cleaner dries.
5. Change cloths often, never use dirty cloths.

6. When cleaning deep, narrow joints wrap the cleaning cloth around a clean narrow metal blade or putty knife to enable force to be applied to the surface being cleaned.
7. Clean only as much area as can be sealed in one hour. If cleaned areas are again exposed to any contamination or weather, the surface must be cleaned again.
8. Close container tightly after use. This prevents the cleaner from evaporating and losing its effectiveness.
9. This fast-evaporating product is particularly suitable for cleaning surface areas prior to applying DNA® Virtual Chrome™, DNA® Black Chrome™, DNA® HolaChrome™, DNA® HolaGrafiX™, DNA® HolaSpeX™ and similar products.
